These Terms of Use are incorporated by reference into the master subscription / license agreement you have in place with AlayaCare, and form part of that agreement. AlayaCare may also update these Terms of Use from time to time. You may not, and you must not, use the ACU Portal unless you (i) have a current agreement; and (ii) agree to these Terms of Use.

### 1. How to Register

ACU includes three types of users with specific viewing and editing permissions within the platform. A Learner User has access to complete the learning plans and courses they have been enrolled into. They will not have access to upgrade content or purchase additional courses. Each Customer will have one Power User License. A Power User has permission to purchase additional licenses and to upgrade and purchase premium content. An Executive User License is a view-only license. An Executive User will have access to view content but will be unable to complete learning plans or courses.

There are two levels of platform content: ACU 101 and ACU 201. Access to content is determined by the license level. License term is specified in each license agreement.

#### 2. How to Access the Content

## 3. Training Catalog

ACU includes a curriculum of learning paths aimed at training and upskilling users on the AlayaCare Cloud platform. As the AlayaCare Cloud platform evolves, learning paths will be updated and added. Supplementary market or industry courses will become available and can be purchased directly in ACU. #### **ACU -- Commercial Terms**

- a) <u>License Start Date and Term</u>. The term of all licenses to the ACU Portal purchased begins upon execution of the Order Form, following which AlayaCare will provision access to the ACU Portal in accordance with Customer's instructions. The term of each license is one-year from the execution of the Order, following which it will automatically renew for an additional term of one year unless terminated by Customer giving written notice to AlayaCare at no less than 30 days prior to the end of the then-current license term.
- b) Payment Terms License fees . Customer's first invoice will be issued upon execution of the Order Form and will be due and payable within 30 days, with all applicable taxes. All license fees are billed annually upfront. Annual renewal invoices will be issued within 30 days of the start of the renewal term.
